<b>4. First Aid Measures</b>	
<i>Inhalation:</i>	If dust is inhaled, remove from contaminated area. Encourage patient to blow nose to ensure clear passage of breathing. If irritation or discomfort persists seek medical attention.

<b><u>5. Fire Fighting Measures</u></b>	
<i>Extinguishing media:</i>	Water spray or fog. Alcohol resistant foam. Dry chemical powder. BCF (where regulations permit). Carbon dioxide
<i>Special firefighting procedures:</i>	Alert Emergency Responders and tell them location and nature of hazard. Wear breathing apparatus plus protective gloves. Prevent, by any means available, spillage from entering drains or water course. Use water delivered as a fine spray to control fire and cool adjacent area. <b>DO NOT</b> approach containers suspected to be hot. <i>Spill response</i>	Remove all ignition sources. Clean up all spills immediately. Avoid contact with skin and eyes. Control personal contact by using protective equipment. Use dry clean up procedures and avoid generating dust. Place in a suitable, labeled container for waste disposal
<i>Containment</i>	Avoid all personal contact, including inhalation. Wear protective clothing when risk of exposure occurs. Use in a well-ventilated area. <i>Engineering controls</i>	<p>Local exhaust ventilation is required where solids are handled as powders or crystals; even when particulates are relatively large, a certain proportion will be powdered by mutual friction.</p> <p>Exhaust ventilation should be designed to prevent accumulation and re-circulation of particulates in the workplace.</p> <p>If in spite of local exhaust an adverse concentration of the substance in air could occur, respiratory protection should be considered. Such protection might consist of:</p> <p>(a): particle dust respirators, if necessary, combined with an absorption cartridge;  (b): filter respirators with absorption cartridge or canister of the right type;  (c): fresh-air hoods or masks</p> <p>Build-up of electrostatic charge on the dust particle, may be prevented by bonding and grounding.</p> <p>Powder handling equipment such as dust collectors, dryers and mills may require additional protection measures such as explosion venting.</p> <p>Air contaminants generated in the workplace possess varying "escape" velocities which, in turn, determine the "capture velocities" of fresh circulating air required to efficiently remove the contaminant.</p>
